

## SBC

The State Building Contract is the European Union budgetary support specifically designed to help countries in situations of fragility or engaged in transition processes towards sustainable development and democratic governance. In 2014-2015, the EU agreed to transfer EUR 355 mln for the needs for stabilisation in Ukraine; fight against corruption; improve management of the national budget and public finances; reform the civil service, support constitutional reforms and electoral legislation. The anti-corruption reform was one of the key objectives of the SBC.
